## **Free School Meal Eligibility – Are You Eligible?**

**Even if you don't wish your child to take up school dinners but you are entitled to free school meals, please do apply as the school will receive extra funding which your child will benefit from. Your child is free to bring in a packed lunch if you wish. You have nothing to lose and everything to gain!**

Families who receive any of the following benefits may be eligible:

- Universal Credit (UC) providing you have net earnings of less than £7,400 a year (£616.67 a month)
- Income Support
- Income – based Job Seekers Allowance (JSA IR)
- Income – related employment and support allowance (ESA IR)
- In receipt of Child Tax Credit, where their earned income is below £16190 and they are **not** entitled to Working Tax Credit.
- In receipt of the Guaranteed Element of Pension Credit
- Supported by the Home Office NASS under part V1 of the Immigration and Asylum Act 1999

If you receive any of the above benefits please complete the attached document and Mrs Johnston will be able to check if you are entitled on your behalf. You do not have to apply to Haringey anymore – we can manage the entire application for you.
